



# AGREEMENT & RELEASE FOR PAINTING OVER GRAFFITI

### BACKGROUND:

The City operates a graffiti prevention program with the support of trained Volunteers and community groups in the removal of graffiti from private property. Property Owners who would like these Volunteers to paint over graffiti on their property must agree to the following mutual promises between themselves and a painter Volunteer.

### AGREEMENT:

As the owner/lessee of the above address, I agree to participate in the graffiti removal program with the following understandings:

1. Owner acknowledges that she/he owns or is responsible for the property listed above and agrees to allow Volunteer(s) to paint over any graffiti found.
2. Owner acknowledges that Volunteer(s) is/are **not** a professional painter(s), and is not associated with, or an agent(s) of, the City of Renton.
3. Owner releases the City of Renton and the Volunteer(s) from all claims, damages or suits, of whatever nature, arising out of the performance of this Agreement by the Volunteer. Owner further understands that this release discharges the above Volunteer(s) from any liability that may result from their work.
4. Volunteer(s) will paint over graffiti using neutral colors such as white, gray, or beige. Property owners are encouraged to provide paint if a closer or exact match is desired.
